

**CASH IN WITH RITAS
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND NOT NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. 1. ELIGIBILITY:

The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant’s full and unconditional agreement to these Official Rules (“Official Rules”) and Sponsor’s decisions which are final and binding in all matters related to this Sweepstakes. 2. SWEEPSTAKES PERIOD:

For purposes of these Official Rules, all times are in Eastern Standard Time (“EST”) or Eastern Daylight Time (“EDT”). Sweepstakes begins at 12:00:00 a.m. EST on January 1, 2026, and ends at 11:59:59 p.m. EST on December 31, 2026 (“Sweepstakes Period”). The Sweepstakes Period is divided into seven (7) grand prize entry periods (each a “Grand Prize Entry Period”) and three-hundred sixty-five (365) entry periods (each an “Entry Period”) as defined in the chart below. Sponsor’s computer is the official time keeping device for this Sweepstakes.
